

The Thing That PUZZLE ME IS, I WAS GIVEN  
25 yrs to Life For Possession of "20 worth  
of Drugs in 2007,"

I'm 68 yrs old with Health Problems  
And Eligible For Prop. 57, Accept I  
HAVE AN OLD CASE IN 1968 THAT PREVENT  
ME FROM GETTING Prop. 57 AND MY  
CURRENT CONVICTION IS NONVIOLENT.

Prop. 57 WAS FOR NONVIOLENT CURRENT  
CONVICTION AND A HEALTH PROBLEM OLD  
MAN IS STILL HERE AND DONT KNOW  
IF STRESS WILL TURN THIS 3 STRIKE  
25 yrs to Life INTO A DEATH SENTENCE  
OR WILL CORONAVIRUS SNEAK INTO MY  
BODY AND TAKE THE BREATH OF  
LIFE IN ME AWAY THAT GOD HAS  
BLOWN INTO MY LUNGS AT BINTZ.

For Prop 57 For Nonviolent Current

I Didn't Deserve a 1st Deg.  
Premeditated Murder Sentence  
25 yrs to Life - That makes this  
Three Strike Sentencing Law so Unfair;  
For habitual criminals with Three  
Convictions for Armed Robbery, only  
Get 20 yrs to Life.

Three Strike Sentence Start with  
25 yrs to Life Sentence the same  
As 1st Deg Premeditated Murder -  
This is so Unfair and the Need  
to Change this Law - to only fit the  
Violent Felony Convictions.

Penal Code Sec 667(d)(1) and Sec 1170.12(b)(1)  
Should be amended to read - on Date of Prison  
Conviction - 1994 and Forward and  
All Prior Convictions Before 1994 be Stricken  
By Court and New Abstract of Judgment sent  
to CDCR to Reduce ~~the~~ sentence from 25 yrs to life  
to Full Primary Term and Release the old convicts
