



TO Whom it may concern:

Hi my name is Joe Reed im a 51 year old Native American. I have been incarcerated going on three years. I Just recently went in front of Board of prison terms in which I was given another year.

Im here on a parole violation so BPH can deny me a year each time until they find me suitable. I have done everything the board had asked of me.

I have a low-RISK assessment from the phyc. Thats the best you can get means im low-risk to offend again. Im a level one with zero points. I just recently had my vio. taken off.

I completed substance abuse and anger management in L-top. Im involved with the native American healing circle. Im waiting on a certificate in the mail from Cimminon.

I have alot of support from family and friends. Got a residential program to parole to also have my wifes house. me and my wife have a small business and I have job offers available. I have sponsors and support from my tribal council along with my wifes tribal council.

I had admitted to drinking alcohol and my agent gave me a 10 day Flash in county Jail. I completed a program in Frisco, then went to live with my wife in porterville CA. My wife Uelda goes to Jail to sit out a Fine. Later her tribe Kicked me out of the house cause im not a tribal member.

Since I have no ties, Family members in the Area and the only reason I got to parole to porterville was I had a place to go and I was married. when I checked into my parole agent in Hanford he said he was sending me back to Humboldt county.

I then told him could I go to a program local as I knew of a few Native American programs. I was trying to stay close to my wife. He asked if I had a drug or alcohol program. I told him I went to a house to pick up a friend and they were smoking meth in which I was triggered by it. He then gave me a U/A which came back negative, sent me to county Jail said I self admitted the use of meth.

I was then released after serving 5 days in Visalia county Jail and was told to report to Humboldt county parole office the next day. once I got to Humboldt I reported like I was told and given a U/A on the spot which came back negative.

my agent P.O Sean burger then took me to a residential program Humboldt Recovery. later about three weeks later I had informed my Agent I was having problems at the program and asked if I could transfer to another one. He informed me to stay put in which I did. the problem worsened and I took it upon myself to relocate to another program. I informed my agent 18 hours later letting him know my whereabouts in which he said its to late he put a warrant out on me. I had left message on his phone a few hours after leaving HRC and told him he could of called me and told me to come in.

This is twice I had asked for help from my Agents and both times there solution is to lock me up. I'm afraid to ask for help now. when I went to the board they dont even ask about my violation of absconding they are holding me cause they said I self admitted the use of meth. I never gave a dirty 1/4 I was only asking for help cause I was triggered. I know I did wrong by leaving HRC and going to another program I accept full responsibility of that. I have one working lung and I'm afraid my violation could turn to be a death sentence. My Family is afraid if I catch the virus they will never see me again im also afraid. I have wrote Gov. Newsom and also have loved ones e. mail him. could you share my letter I'm asking for support from all. And thank everyone for the gift.
