I Just wanna say thanks its a good feeling knowing its people out there that still care & consider us actual humans. Its a good feeling not being judged the bags were very thoughtful & unexpected it surprised us to the fullest. So thanks for that also, I feel like Yall group are fighting our fight & its refreshing. Ive been here since October 2019 just sitting i was post too get the ucp program but the coronavirus has stopped all movement. its been going on for a while now so I pretty much lost hope off getting out & going home.

A little about myself my name is tony Reagan im from SF, CA im 25 I came from marin county. I got arrested for grand theft with 2 other co-defendants Both whom are out right now. During my trail I was only offered one deal 4 years at 80% while my co-di's took a 1170(H) and the other one took 9 months with half & probation. I was ALSO post to take a 1170(H) 5 year split sentence where I do an actual year in Jail & 3 years probation so it was a 2/3 split I signed the deal & everything at my sentencing my Judge said I couldn't/didn't qualify for 1170(H) & that any deal he could give me would be no more than 5 but no lesser than 4. so I took the 4 years I really didnt have a good lawyer it was a lot of conflict from the start. Both my co-di's were appointed private attorneys & I got a truck public defender that never really fought for me the D.A only offered one deal my whole 9 month stay my lawyer never got it lowered or my strike struck due to it being a juvenile strike. so I say all this too say that in January 2020 A law was passed where you cant use past case & charges/strikes against you. Im writing you because my support system on the streets is slim & very non-active. I dont have the resources to do the job i need done nor the knowledge.

Basically I wanted to see if I can go to court & get re sentenced based on the fact of the laws that passed in jan & I was sentenced in October.

I know this not your Job or responsibility but i was curious is there a program I qualify for or some type of support group that works with your program or that is active with yall.

If so could somebody please help me. I have all my paper work lawyer contact info everything

I was rail roaded.

Never have I seen somebody get a conspiracy charge & the court let the co-defendants take deals that didnt affect each other. They followed their own rules in main & im pretty sure the moves they were pulling was illegal.

They threatened my co-def's into taking Deals by telling them how i was gonna get barged.

my involvement in the actual crime was minum at basis.

I need help If you can help thanks even a response would be welcomed & greatly appreciated

If you guys cant help I understand also & I still wanted to say thank you for giving me the time to vent

Im a changed man, Ive learned my lesson & my overall outlook on life has changed drastically I just wanna go home to my family. I dont see how I got 4 years & both my co defendants did under a year & they both had more charges than me.

I dont know I just need a blessing or a miracle I dont wanna give 4 years of my life for no grand theft

I feel like so far this tragedy has brought us closer. However, we're still not able to visit our family or thoroughly contact them. Yes, we now get free phone calls, but they're only 10 minutes a cell, and they're not guaranteed.

As far as cleaning, there's not enough supplies being passed around (Bleach, Disinfectant). Toilets not being cleaned or phones.

Conditions inside have worsened. We're on 24/7 lockdown. We eat in a cell that we're not given a chance to clean. There's no clean air being circulated, so we're breathing some air.

The people who were waiting on buses are losing out. I've been endorsed for 60 days. I've been here for 8 months. I'm not getting my 66% no packages, no visits, no classes, no type of way to earn any type of credit. To go home early, no groups, no AF classes. So it sucks. I was poised to be on a mainline getting ready to come home, now I'm stuck, eating all my meals in my cell while other people are still going to chow hall.

I feel like the people who are endorsed should receive some privileges they would get on mainline, cause it's not our fault we're stuck.

At least we should be able to get our half time or 33% or 66% be able to go 220 at canteen. Also be able to get regular canteen lists.

I feel like we should get phone calls everyday. Some people have a lot of family & can't cover everybody in 5-10 minutes.

More cleaning supplies should be passed away at least once a week (gloves, Bleach, Disinfectant, hand sanitizer). We're in here caged up & then there's the fact who's to stop us from getting sick from staff who are going out into the real world coming back with us.

The only way you can help is too continue to be our voice. maybe
do an interview or two inside reception to see how rough it really
is.

Keep calling up here & telling them what we need. maybe
a way to earn our extra credits.

Some early releases for people who don't qualify in the
0-90 days here what about a year or under non violent
crimes or something level 2 or down all people with 90 go to
50% cause we can't get out of reception our just something

I'm pose to go home I been in jail 26 months on
in 4 wit 66% I'm pose to do 28 months.
